

Notice of Gravel Road Petition.

NOTICE is hereby given that a petition signed by more than fifty freeholders and voters of Jackson township, Hamilton county, Indiana, will be presented to the Board of Commissioners of said county, at the regular September, 1908, term of said Board asking for the improvement of a certain highway already laid out and established in said township, which petition is in the following words and figures, to-wit:

To the Honorable Board of Commissioners of said County:—

We, the undersigned, residents and freeholders and voters of Jackson township, Hamilton county, State of Indiana, being more than fifty in number, would respectfully represent and show to your Honorable Board that said township of Jackson has within its bounds the incorporated towns of

Cicero, Arcadia and Atlanta, each of said towns having a population of less than thirty thousand (30,000) inhabitants, and we respectfully petition your Board for the improvement of a certain highway already established, by grading, draining and paving with gravel, under and pursuant to an Act of the General Assembly of the State of Indiana, concerning highways, approved March 8th, 1905, and amended March 2nd, 1907, together with all other amendments thereto and that said highway be improved as hereinbefore indicated on the following route, to-wit:—Commence at the north east corner of section 29, township 20 north, range 4 east, thence run south on the highway already established to the southeast corner of section 32, township 20 north, range 4 east. All of said highway being in Jackson township, Hamilton county, Indiana. That said proposed improvement is less than three miles in length and connects with a free gravel road at both the north and south ends thereof. And that a United States Rural Mail route passes over a part of said proposed highway. Your petitioners recommend that said highway be of the width of 32 feet, and the grade 24 feet between shoulders with good side ditches, sewers and bridges sufficient for proper drainage, and that the road thereof be improved by paving with six cubic yards of good gravel to the lineal rod. Your petitioners would further show that the benefits to be derived by said proposed improvement will exceed the costs and damages of said proposed improvement, all of which is respectfully submitted,
