The record needed to answer your inquiry is not in our files. If the record were here on July 12, 1973, it would have been in the area that suffered the most damage in the fire on that date and may have been destroyed. The fire destroyed the major portion of records of Army military personnel for the period 1912 through 1959, and records of Air Force personnel with surnames Hubbard through Z for the period 1947 through 1963. *However, complete records cannot be reconstructed.*

We are pleased to enclose NA Form 13038, *Certification of Military Service*. This document verifies military service and may be used for any official purpose. A seal has been affixed to this document to attest to its authenticity. The information used to prepare the enclosed NA Form 13038 was obtained from an alternate record source.


